RIGHT TO CANCELLATION

WITHIN 3 BUSINESS DAYS AFTER YOU HAVE BECOME A INDEPENDENT REPRESENTATIVE YOU HAVE AN ABSOLUTE RIGHT TO RESCIND YOUR ACCEPTANCE AS A QUALIFIED INDEPENDENT REPRESENTATIVE.

YOR IS A WHOLESALE & RETAIL PRODUCT COMPANY

A INDEPENDENT REPRESENTATIVE CANNOT EARN COMMISSIONS, BONUSES, AND OVERRIDES WITHOUT SELLING AND/OR PURCHASING THE REQUIRED PRODUCT VOLUME AS SET FORTH BY THE COMPANY IN REGARDS TO PERSONAL PRODUCT VOLUME AND GROUP PRODUCT VOLUME. A INDEPENDENT REPRESENTATIVE CAN GENERATE INCOME THROUGH SELLING PRODUCTS TO REGISTERED RETAIL CUSTOMERS AND SELECT CUSTOMERS, AND IS NOT REQUIRED TO BUILD A DISTRIBUTION COMMUNITY TO PARTICIPATE IN THE YOR COMPENSATION PLAN. NO MONEY WHATSOEVER CAN BE EARNED FROM THE MERE ENROLLING OF REGISTERED RETAIL CUSTOMERS, SELECT CUSTOMERS OR INDEPENDENT REPRESENTATIVES. A INDEPENDENT REPRESENTATIVE WHO DOES NOT SELL PRODUCTS OR HELP OTHERS SELL PRODUCTS WILL SIMPLY NOT GET PAID.

NEVER PRESENT YOR INDEPENDENT REPRESENTATIVE AS A SALARIED POSITION

YOR IS AN ENTREPRENEURIAL ENTERPRISE. INCOME IS GENERATED THROUGH PERSONAL EFFORTS AND COMMITMENT TOWARD YOUR BUSINESS; THERE ARE NO GUARANTEES OF INCOME. ONLY ACTIVE INDEPENDENT REPRESENTATIVES WHO WORK HARD TO SELL PRODUCTS WILL EARN COMPENSATION. NEW INDEPENDENT REPRESENTATIVES AND POTENTIAL INDEPENDENT REPRESENTATIVES SHOULD NOT MISPERCEIVE THE PRESENTATION TO BE A JOB INTERVIEW. YOR IS AN OPPORTUNITY IN REGARDS TO OWNING YOUR OWN BUSINESS AND SHOULD NEVER BE DISPLAYED AS A JOB OPPORTUNITY. ANY CHARGES OF FALSE OR MISLEADING CLAIMS, ONCE PROVEN, WILL UNDERGO INVESTIGATION BY THE COMPANY AND MAY RESULT IN IMMEDIATE TERMINATION.

ABSOLUTELY NO MINORS

A PERSON UNDER THE AGE OF 18 IS CONSIDERED A MINOR AND CANNOT ENTER INTO A CONTRACT WITH YOR. A YOR INDEPENDENT REPRESENTATIVE WHO KNOWINGLY SOLICITS A CONTRACT FROM A MINOR IS IN VIOLATION OF THE YOR TERMS AND CONDITIONS, POLICIES AND PROCEDURES, AND WILL UNDERGO INVESTIGATION BY THE COMPANY AND MAY RESULT IN IMMEDIATE TERMINATION.

UNAUTHORIZED TRANSACTIONS

ANY UNAUTHORIZED TRANSACTIONS PROCESSED BY INDEPENDENT REPRESENTATIVES, IN TERMS OF, BUT NOT LIMITED TO, FALSE MULTIPLE TRANSACTIONS, PROCESSING ENROLLMENT/ORDER FORMS WITHOUT PROPER CONSENT OR FULL DISCLOSURE OF PRODUCT, WILL UNDERGO INVESTIGATION BY THE COMPANY AND MAY RESULT IN IMMEDIATE TERMINATION.

EXCESSIVE PURCHASES OF INVENTORY PROHIBITED

THE COMPANY STRICTLY PROHIBITS ANY INDEPENDENT REPRESENTATIVES FROM PRACTICING, TRAINING, ENCOURAGING, OR FORCING UPON OTHER INDEPENDENT REPRESENTATIVES OR CUSTOMERS, TO BUY MORE THAN WHAT IS REASONABLY CONSUMABLE OR RESELLABLE FOR THE SOLE PURPOSE OF QUALIFYING FOR COMMISSIONS, BONUSES, OR ADVANCEMENT IN THE COMPENSATION STRUCTURE. AT NO POINT ARE INDEPENDENT REPRESENTATIVES ALLOWED TO PURCHASE MORE PRODUCTS IF THEIR PREVIOUS PRODUCT ORDER IS NOT MORE THAN SEVENTY PERCENT (70%) SOLD OR CONSUMED. ANY SUBSTANTIATED REPORTS OF SUCH BEHAVIOR AMONG ANY INDEPENDENT REPRESENTATIVES WILL UNDERGO INVESTIGATION BY THE COMPANY AND MAY RESULT IN IMMEDIATE TERMINATION.

ON NO ACCOUNT MAKE OR DISPLAY ANY UNREALISTIC SALES AND INCOME CLAIMS

ANY IMPLICATION OR PRESENTATION THAT DISPLAYS YOR AS A GET-RICH-QUICK SCHEME IS WRONG AND MISLEADING. DO NOT COPY AND OPENLY DISPLAY ANY YOR ISSUED CHECK OR BOAST ABOUT ANYONE'S INCOME.
